1. GREEN AS GRASS- For very beginners youth to Adult to have a chance to experience Mountain trail. Never to have shown Mountain Trail. *CAN BE SHOWN INHAND OR UNDER SADDLE.* Mini's, mules and horses allowed.
2. GREEN IN HAND- Any Equine, any age, green horse or green rider is less experienced and defined as a horse/rider, may not compete in open division at the same competition with no cross entry permitted. Never have won more than (2) wins or to have won a championship in this category. *TO BE SHOWN IN HAND*
3. MINI IN HAND- Any MINI EQUINE, donkey or horse any age, to be shown on the green map.*TO BE SHOWN IN HAND*
4. GREEN HORSE- Any Equine, any age, green horse is less experienced and defined as a horse, may not compete in open division at the same competition with no cross entry permitted. Never have won more than (2) wins or to have won a championship in this category. To be shown under saddle. *TO BE SHOWN UNDER SADDLE!*
5. GREEN JUNIOR/AMATEUR- Any Equine, any age, JUNIOR OR AMATEUR RIDER is less experienced and defined as a rider with not more then two(2) wins in this division, may not compete in open division at the same competition with no cross entry permitted. Never have won more then (2) wins or to have won a championship in this category. To be shown under saddle. *TO BE SHOWN UNDER SADDLE!*
6. GREEN RANCH HORSE- Any Equine, any age, green RIDER is less experienced and defined as a rider with not more then two(2) wins in this division, may not compete in open division at the same competition with no cross entry permitted. Never have won more than (2) wins or to have won a championship in this category. To be shown under saddle. *TO BE SHOWN UNDER SADDLE!*
7. NOVICE IN HAND- The Novice riders & horses have more experience competing in Mountain Trail (Area Trail) classes with not more then five (5) wins or have not won a championship in this category
8. NOVICE HORSE- The Novice RIDERS have more experience competing in Mountain Trail (Area Trail) classes with not more then five (5) wins or have not won a championship in this category.
9. NOVICE JUNIOR/AMATEUR- The Novice JUNIOR AMATEUR RIDERS have more experience competing in Mountain Trail (Area Trail) classes with not more then five (5) wins or have not won a championship in this category.
10. NOVICE RANCH HORSE-The Novice RIDERS have more experience competing in Mountain Trail (Area Trail) classes with not more then five (5) wins or have not won a championship in this category.
11. OPEN IN HAND- Obstacles may be performed at the walk, jog,(or gait) , lope or canter. Horse and rider have established skills to negotiate difficult obstacles, and are conditioned to compete over a longer course.
12. OPEN JUNIOR/AMATEUR RIDER- Obstacles may be performed at the walk, jog,(or gait) , lope or canter. Horse and rider have established skills to negotiate difficult obstacles, and are conditioned to compete over a longer course. 18 years as of Jan 1 the current year, who participates in equestrian sport for pleasure only, and has not received any payment for training horses, or coaching riders the equine industry.
13. OPEN HORSE- Obstacles may be performed at the walk, jog,(or gait) , lope or canter. Horse and rider have established skills to negotiate difficult obstacles, and are conditioned to compete over a longer course. *TO BE SHOWN UNDER SADDLE.*
14. OPEN RANCH HORSE- Obstacles may be performed at the walk, jog,(or gait) , lope or canter. Horse and rider have established skills to negotiate difficult obstacles, and are conditioned to compete over a longer course. *TO BE SHOWN UNDER SADDLE.*

15. GAMBLERS TRAIL CHOICE-(**SATURDAY ONLY**). WINNER GETS A BUCKLE! This is open to all levels of horse and rider. There will be three judges. This will be a green level course with the 4th obstacle for each judge having a choice of 3 obstacles. The easy choice with regular scoring, the harder choice with 2 extra points added for the attempt, and the hardest choice with 5 extra points for the attempt.

At the end of the course there will be the Gamblers Choice. If you choose to tackle this challenge and succeed you will earn 20 extra points, if however you choose and fail you will lose 20 points off your total score. What will you do?

16. LEAD LINE- CHILDREN UNDER 10 (**FRIDAY BEFORE LUNCH**) Prizes to all competitors. We will have a very basic obstacle course for the young ones. You can lead your child, walk with them or let them ride on there own. We will be placing winners , all will be judged but all will get prizes. Each Judge will do her own places awards to all. This will be a FREE class. We want to encourage our young and up and coming riders to welcome them to Mountain trail events.

EVERY HORSE OWNER/PARTICIPANT SHALL CAREFULLY READ THIS NOTICE BEFORE SIGNING. NO OWNER/PARTICIPANT WILL BE ALLOWED TO PARTICIPATE IN EQUINE ACTIVITIES (CALLED THE ACTIVITY) OR HAVE THEIR HORSE BOARDED PRIOR TO READING AND SIGNING THIS FORM. TO: Canoa Farms, Ron Stolp and Kelly Allen their directors, officers, employees, representatives, agents, officials, volunteers, business operators and site property owners, (all of them collectively called the HOST). I am aware and understand that there are Inherent DANGERS, HAZARDS AND RISKS, (collectively called RISKS) associated with Equine Activities. I Acknowledge that these Inherent "RISKS" of Equine Activities mean those DANGEROUS conditions which are an integral part of Equine Activities, including but not limited to:

1. The propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and/or damage to property in their vicinity;
2. The unpredictability of an equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. The equine's response to certain hazards such as surface and subsurface objects;
4. Collisions with other equines, animals, people and objects;
5. The potential of any participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or to act within his or her ability. I understand that injuries resulting from such "RISKS" are a common and ordinary occurrence associated with Equine Activities. I freely accept and fully assume all the "RISKS" and the possibility of personal injury, death, property damage or loss from being a Participant. I acknowledge that it remains my sole responsibility to act in such a manner as to be responsible for my own safety and to Participate within my own limits. In consideration of the "HOST" Boarding my "HORSE(S) or permitting my Participation in the "ACTIVITY", I together with my heirs, executors, administrators and assigns, (Collectively called my "Legal Representatives") agree:
 1. To WAIVE ALL CLAIMS that I may have against the "Host" and
 2. To RELEASE THE "HOST" FROM ANY AND ALL LIABILITY for any loss, damages, injury,, or expense that I or my "Legal Representatives" may suffer as a result of my horse(s) being Boarded or my Participation in the "ACTIVITY" due to any cause whatsoever INCLUDING NEGLIGENCE ON THE PART OF THE "HOST" and,
 3. TO HOLD HARMLESS AND INDEMNIFY THE "HOST" from any and all liability for any injury to the HORSE(S) or any property damage or personal injury to any third party resulting from my "HORSE(S) being boarded or my Participation in the "ACTIVITY" and,
 4. To maintain in effect a minimum of \$1,000,000.00 third party liability insurance on the HORSE(S) while boarded. I have read and understand the Rules of the Boarding facility and the "Activity" which apply to me. I agree to abide by those Rules and Acknowledge that a breach of the Rules may among other things, result in my expulsion from the Boarding facility or the "ACTIVITY". Before I signed this Release and Acknowledgment, I read it and I state that I understand it. I am aware that by signing this Release and Acknowledgment, I am waiving certain legal rights which I might have against the "HOST", or, if I die, by signing this Release and Acknowledgments, I am waiving certain rights that my Legal Representatives may have against the "HOST".

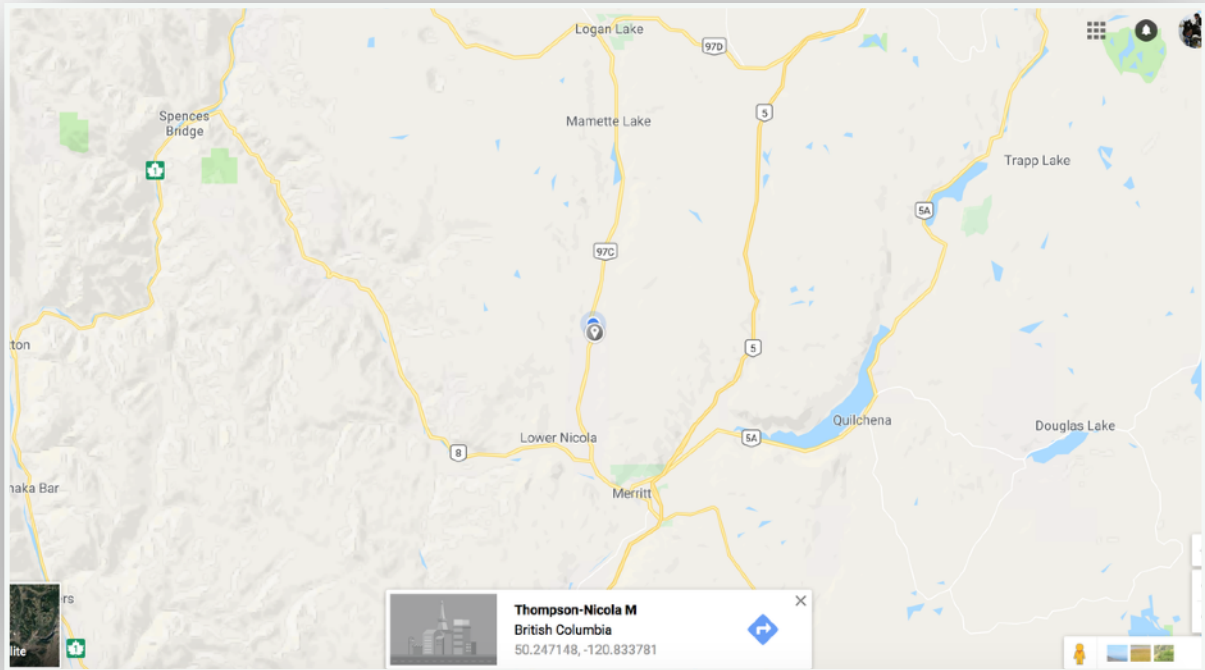

DIRECTIONS AND LOCATION

11460 Hwy 97C, Merritt BC - DO NOT GOOGLE ADDRESS -Coming from Merritt you go about 5 minutes out of town towards Spencer Bridge, turn up Hwy 97C on the right just out of town also known as Mamit Lake road go up 8 miles or 14k you will come to a big "S" turn that says 40k right at the eight-mile road sign keep going on the highway until you see the next driveway on the right. You will see a large Turquoise rock out front. Parking for all horse trailers is in the lower field.

If coming from or from the North or Kamloops take the Logan Lake turn off go through Logan Lake and take Hwy 97C to the left. We are 24k down from Logan Lake 9k from Mamit Lake. When you are getting close look for Steffens road on the left about a mile later we are the first driveway on the left just past the mailboxes on the right. if lost call 250-378-1670
