

THE HUNTSMAN STALLION BREEDING CONTRACT 2024

PER DOSE FROZEN SEMEN

Stallion: The Huntsman

Stallion Owners: Ron Stolp & Kelly Allen

Standing at: Canoa Farms 11460 Hwy 97C Merritt, BC V1K 1M6

This contract applies to the breeding of the mare known as _____ (the "Mare"), owned by _____ (the "Mare Owner"), and the stallion "The Huntsman" (2004 APHA/PtHA, 7 panel NN, homozygous tobiano) owned by Ron Stolp and Kelly Allen (inclusively referred to as the "Stallion Owner").

The Purchaser and the Stallion Owner agree to the following terms and conditions:

1. BREEDING:

- This contract is for the sale of frozen semen "by the dose" for The Huntsman.
- There is no guarantee of a pregnancy or live foal with this contract.
- All Breeding Fees must be paid in full prior to the shipment of semen.
- The Stallion Owner must be advised within 45 days of any pregnancy.
- Any frozen semen purchased within this contract shall be used in 2024.
 - Should semen be retained by the Purchaser and used in another breeding year, the Purchaser agrees to pay any difference in pricing from this contract to the current contract should the retained semen result in pregnancy prior to the mare being included in any breeding reports or foals registered.

2. FEES:

- Semen Single Dose Fee for The Huntsman is:
 - \$500.00 for frozen semen (plus handling and shipping fees)
- Each dose will contain sufficient progressively motile sperm for one insemination.
- The Purchaser is entitled to one foal per dose of semen purchased. Should one dose result in more than one foal, the Purchaser agrees to pay the value of another dose of semen.
- All fees are due immediately upon signing of the contract and all risk of loss transfers immediately to the buyer.
- Storage for frozen semen is included at Winsome Meadows Reproductive Services for 30 days from date of purchase, shipping and vapour/dry shipper rental fees are the responsibility of the Mare Owner

3. MISCELLANEOUS:

- The Stallion Owner bears no liability for any information contained on any website or social media platform that is or may become incorrect, out of date or inconsistent with any terms of this Agreement.
- The Mare Owner agrees that notwithstanding any information to the contrary displayed on any website or social media platform, the parties' rights and obligations are as set out in this Agreement only.
- The Mare Owner assumes all responsibility for the care, custody, control, and condition of the Mare and bears all risk of loss or damage to the Mare, whether by death, disease, injury, infection or other cause during the Breeding and afterwards.

- The Mare Owner agrees to indemnify, release, and hold harmless the Stallion Owner from any and all claims, demands, damages, suits, legal fees, obligations or liabilities of any kind, known or unknown, in any way related to or arising from the Mare or the breeding or insemination of the Mare.

This Agreement shall be governed by the laws of British Columbia, and the parties hereby agree to the Provincial Court of British Columbia having exclusive jurisdiction over all matters or disputes arising out of this Agreement.

Frozen Semen:

Frozen semen handling fee - \$60 CAD per occurrence

Dry shipper rental for frozen semen (available only within Canada) - \$18 CAD per day + \$75 liquid nitrogen charging per occurrence - \$1500 deposit required (credit card required on file)

*All fees are subject to change and subject to 5% GST.
